Supplementary Item No (Department Item) 10

Agenda :-

To peruse the decision of STA in its meeting held on 04-01-2018 vide departmental item 1 so as to reconsider the present stage of implementation of ‘D3 Circular’ issued under D3/875/STA/2005 by the STA, Kerala on the basis of the Study Report submitted by the R & D Team (Law)

The modifications which are to be implemented in the D3 Circular are as follows:

I The various operators in the private stage carriage sector demanded not to vary the existing timings of ordinary stage carriages since it causes unhealthy competition and clash between stage carriages. Considering the objections and suggestions of the interested parties and the fact that the present timings of ordinary stage carriages are proper, the same shall be maintained as such.

II.

The Government vide GO(P) No 6/2017/Trans dated 15-03-2017 in SRO No. 127/2017 amended the Kerala Motor Vehicles Rules, Rule 2 in Sub clause (oa) introducing the definition to “Ordinary Limited Stop Service” as follows:-

“2(oa) “Ordinary Limited Stop Service” means a service, which is operated on a route having a distance of not exceeding 140 kms with limited number of stops, having at least one stop in every fare stage”.

Even though separate timings were issued to Ordinary Limited Stop Service on the basis of the common judgment in WP(C) No. 23569 of 2013 dated 07-11-2013 of the Hon’ble High Court, on the basis of the GO(P) No 6/2017/Trans dated 15-03-2017, the term Limited Stop Ordinary Service is entered in the D3 Circular with slight variations in the existing timings.

III The recommendation No 3(d) of the D3 Circular should be modified as

- (1) City/Town roads shall mean the roads within the City/Corporation subject to the condition that concerned Regional Transport Authority can fix the City/Corporation limit considering the density of population and traffic congestion irrespective of the City/Corporation limit.

2 Considering the traffic density and parity of the area, concerned Regional Transport Authority can enhance the running

time, without reducing the running time prescribed in the modified D3 circular and the revised timings should be simultaneously intimated to the sister Regional Transport Authorities.

IV An additional recommendation as 3(e) also introduced in the circular adding Ghat Road with suitable running time for the different classes of Stage Carriages

3(e) Ghat Road shall mean the roads going through the hilly areas in the Eastern and Western Ghat portions of Kerala”

V Revised recommendations for the minimum running time for different classes of Stage Carriage Services for different types of roads should be fixed as follows:

3. Limited Stop Ordinary Services Maroon (colour value = #871414) with three equally spaced white lines below the height of the wheel arch.
